

# Out and About— Members' News

#### Carriage Proficiency Testing—part II/level 1 Anna Klumpp

So what are the requirements for level I? It is suggested that you get a syllabus for all the possible questions that could be asked. However, if you know someone with a syllabus, it is ok to just check that out, as it is not a good idea to go uninformed about what might be expected. The syllabus will have an application for the testing but you can also get the application on line. There is a fee for the test.

Each level has various units. Level I has three units, all of which can be done in one testing day or done separately. It takes about 1 1/2 hours to complete all three units. Someone must be able to demonstrate practical driving and stable management for the single horse. It is not necessary to be taking lessons or to be actively showing in any way.

The three units of level I are Preparing to Drive, Practical Driving, and Horse knowledge and Care. It is overwhelming to look at all the requirements and possible things that an evaluator can ask, but what I found to be the typical experience is that if you present your horse clean and groomed, can talk about the tools that you use, have a clean harness and can also talk about the typical materials used for cleaning harness, you are set for most

of Unit I (preparing the horse to drive) as well as some of Unit III. As long as you have a reasonable explanation for why you choose to do something different for your horse, the evaluator will accept your knowledge. For instance, my minis are not shod; their hoof wall is so thin that there is no nail thin enough to keep on a shoe and there are no farriers in my area who do the glueons. And for those who love easyboots, they don't come in mini size, a good enough answer for why I did not have shoes on my minis. I was expected to know something about shoeing and using studs for road driving. The evaluator usually asks questions about the horse that you present, so feeding and pasturing and health care issues should be answered about what is typical for your horse. Evaluators seem particularly concerned about colic and founder, as it seems that they believe that many owners would not recognize the signs of these illnesses in their horse. Many of these questions about horse care are basic. On of the basic questions is about what kind of watering system you use in your pasture. What they want to hear is that you keep the trough filled and cleaned

and how you go about doing it and how often. Anyone who cares about their horse most likely cleans the trough and keeps it filled and free of ice in the winter. Perhaps the most difficult questions are those about poisonous pasture plants, but go to your ag center and get a list of the most common plants for your area if you do not already know. When you have one evaluator, there is no clear beginning or end of the three units, so some of the questions could be asked while waiting to hitch or even when driving to the arena. The driving unit (Unit II) is also more-or-less basic for someone with some experience. You must demonstrate that you can put-to, using an assistant to head the horse and do it safely. The assistant cannot give you any clues or help you in any way. It is the driver who must give them direction as well as tell the evaluator how to properly get into the carriage. You may have to name parts of the harness as you hitch. While assisting with one person's test, Andy kept asking for the special name for the bearing rein terret, which so far, I have not found in any of my books. He says it is called the "C Hook?. Then there is the issue of keeping the reins safe while putting to, and unhitching. I found that having tested with two different people at this time, there are different methods for tying up reins. Remember, you have some one heading the horse.

use, take the information graciously and try to demonstrate that method when you return and start to unhitch.

The driving itself is done in an arena. Your horse must be at least 5 years old and have had two years of any kind of driving experience. You must drive a serpentine, a 20 meter circle and halt (reins in one hand). The circle and serpentine, as well as all the driving, can be done two handed—no particular method required. This must be done both directions and the 20 meter circle is not precisely measured. There will also be a few cones set out and the driver will be expected to negotiate those. There is no requirement for the length of time the driver has been driving but this is not a test for a new driver. On return to the barn, again, unhitch safely using your assistant TO HEAD THE HORSE. Make certain that you undo your traces last (this is what they are watching for).

With this part finished, the evaluator will typically give you feed-back as to whether or not you passed the test. If you do not pass one of the units you do not have to repeat the passed units, only the one not passed. Also, the syllabus says there can be three different evaluators, but what I have seen is that one person does all three parts.

I did the level I in Kentucky, found it a challenge, but interesting and fun. When asked a question, I could give more than enough information 4 and did not find anything that

I could not answer. Having been driving for over 10 years and keeping horses for over 25, I found that most of the test was just about things that I do routinely. So—with this under my belt, I decided that getting another Level would be easy as could be.

In the next installments, this easy, "stroll-in-the-park" starts to become more of a driving stress test.

If anyone is interested in taking Level 1 at an ADS event, I would be willing to spend some time going over the information and try to help you prepare for the test. Again, you do no have to be a CAA member to test at Level I.

Next month: Road testing and Level II.







#### American Horse Council Washington Update

Congress is due to take up two tax hills that deal with 'estate taxes' and 'other tax provisions which expire at year-end, including extension of the tax incentive for "conservation easements."

Estate taxes are scheduled to go to zero on estates of people dying in 2010. HOWEVER, the taxes WILL COME BACK in 2011 on estates over \$1 million with a top tax rate of 55%. This will effect many 'small' farmers whose total property values will exceed the \$1 million figure (including land value, equipment, livestock and more). While the \$1 million figure sounds like a LOT of money, many

farmers, in-

cluding horse farmers, will be caught in this change. Many will be forced to sell their farms just to pay the taxes. So much for saving the farm industry. The current tax applies to estates over \$3.5 (\$7 million for couples) with a top tax rate of 45%

schooling show.

A second tax bill working its way through Congress, but not yet finalized or introduced, would extend over 40 tax provisions which are due to expire at the end of 2009, commonly called the "extender" bill. Currently, certain farm machinery and equipment can be depreciated over five years. This will now expire at the end of 2009.




New equine WN virus vaccines have been approved by USDA. Called 'Vetera' it is manufactured by Boehringer-Ingelheim and is "the first new approach to a killed West Nile virus vaccine since 2001". There are 3 new vaccines in the Vetera WN line. 1st is a monovalent containing only a vaccine against WN. 2nd combines WN with Eastern Equine Encephalitis (EEE), Western Equine Encephalitis (WEE) and tetanus. 3rd combings all the above plus Venezuelan Equine Encephalitis (VEE).






