The following reflects subjects discussed:

- 1. Minutes of Last Meeting the board approved the minutes as written in the newsletter
- 2. Treasurer Report The board approved the February and March 2007 treasurer's reports as written by Donna Hurst. The total balance at the end of March was \$12,057.52. This includes an additional CD that was recommended by George Parris.
- 3. Sunshine Report Nothing to report at this time.
- 4. Membership Renewals To date we have 23 Individual and 16 family(35 members) renewals for a total membership of 58 individuals. 8 families and 23 individuals have yet to renew for 2007. The board voted to add a bright colored flier to the newsletter to remind members to send in their response.
- 5. By-Laws A special letter has been sent out on the by-law changes and the vote will be held after the drive at the Redden Jester Tract on April 22, 2007.
- Next Board Meeting The next BOD meeting will be held on 5/11/07 after the setup for the horse show at the Denton 4H Park.
- 7. May 12 Horse Show Orders are in for trophies and ribbons. We still need sponsors and volunteers to work the show. The food committee met for a short meeting after the BOD meeting.
- 8. <u>DEC Dinner Dance</u> Paula and Peg reported the event was very successful and generated approximately \$7,000 profit in support of their club's efforts.
- 9. DEC Expo Paula and Peg reported that approximately 5,000 people came through the expo, which had 12 clinicians and lots of participation in the show of breeds. Looking forward to another one next year.
- 10. <u>Dick Chance</u> Kay brought the BOD up to speed on Dick's condition. He has had a stint put in and is presently

coming along in the Corsica Rehab and Nursing Home in Centerville at 205 N. Armstrong Ave.

11. MD Horse Council Mtg. - Many horse groups from the area will get a chance to explain what their groups do at an April 18th meeting at the Tuckahoe Equine Center. Sherry Harris volunteered to make a presentation for the DDC.

- 12. New Club Address The board voted to change the address to John Bolinski's at 986 Irishtown Rd., North East, MD 21901-4404. Since John is secretary and also handles the taxes and insurance, the board felt if made sense.



B) Budgets

- 1. Prior to the December meeting, the outgoing Board will prepare a proposed budget for the upcoming year. At minimum, the budget will include all anticipated operational expenses, such as insurance costs, newsletter expenses, etc., and the estimated income from membership dues. The proposed budget will be presented at the December meeting and must be approved by the incoming Board.
- 2. Prior to the February meeting, the new Board will prepare a revised budget to reflect the estimated costs for non-routine activities and events for the year, and the amount and sources of income needed to pay those costs. The revised budget will be presented at the February meeting after being approved by the Board.
- 3. A budget will be prepared for all activities or events not included in the approved annual budget where the estimated cost exceeds \$200.00. All activity budgets require approval by the Board prior to the expenditure of funds.
- C) Expenditure of Funds
 All expenditures of Club funds require approval by the Board,
 except as explicitly described by the following:
- 1. The host or organizer of a Club-sponsored pleasure drive may be reimbursed for expenses incurred during the event for up to \$100.00 without prior approval. Receipts or other proof of money spent is required.
- 2. The Board is authorized to pay any and all normal and/or recurring Club bills included in the approved budget for the year. All such expenditures will be reported to the general membership at the next regularly scheduled monthly meeting.
- 3. The Board, by majority vote, is authorized to expend Club funds to pay one-time or non-recurring operational expenses not included in the approved budget up to \$200.00. All such expenditures will be reported to the general membership at the next regularly scheduled monthly meeting.
- 4. The Board, by majority vote, may expend up to \$200.00 per month to conduct business directly related to the Club's purpose and objectives. All such expenditures will be reported to the general membership at the next regularly scheduled monthly meeting.

5. Should the membership decide by majority vote to dissolve the Club, all monies and property will be dispersed to other exempt organizations in accordance with Federal Publication 557 for a 501(C)7 organization

Article V - Officers

The officers of the Club are: President, vice-president, secretary, treasurer and three directors. Together this is considered the Board.

- A) Each officer will serve a one-year term and must have been a member for at least one year at the time of nomination.
- B) Each director is elected for a two-year term, and must have been a member for at least one year at the time of nomination.
- C) Elections will be held during each December meeting. In preparations for this elections, a nominating committee will be named by the president, and the slate must be presented to the membership via the newsletter at least one month prior to the December meeting. Additional nominations for each office may be made at the meeting.
- D) No proxy or absentee votes are permitted.
- E) Voting is done by ballot.
- F) A vacancy occurring in any office except the presidency is filled by appointment by the Board and will be effective for the remaining unexpired term.
- G) Any officer or director absent for two meetings per year may be relieved of the responsibilities of that office by a majority vote of the Board of Directors, and a replacement shall be appointed as directed in the above clause.
- H) Upon the vacancy of the office of president, the vice-president assumes the position for the remainder of the unexpired term.
- I) An officer or director may resign from office by submitting a written resignation to the Board.
- J) Minimum duties of each office follow. Additional duties may be assigned.
- 1. President: Preside at all business meetings, voting only as a tiebreaker. Set committee chairpersons, appoint the nominating committee, and perform all such duties as prescribed by the current Robert's Rules of Order, the parliamentary authority adopted by this Club.

STANDING RULES

The president shall solicit volunteers to handle such duties as newsletter editor/publisher' education leader, safety officer, pleasure drives coordinator, nominations committee, trailer towing and storage overseer, sunshine correspondent, and historian.

A membership roster is to be prepared and distributed to members as soon after January 31 as possible.

Members may borrow Club-owned reference materials and tapes, but must first sign them out though the vice-president, who is in charge of and responsible for Club assets and supplies.

Members using the Club trailer for show or event appearances and displays and selling items are expected to keep the inventory up-to-date. Store all equipment and supplies neatly before returning the trailer to its designated storage location.

Archives shall be stored in the trailer, except for those items that are heat or cold sensitive, such as video tapes and photographs. The vice-president is in charge of all these items.

All members are given a copy of Club by-laws and a membership roster immediately upon becoming a member or as soon after as is possible. Members who do not have a copy of the by-laws should contact the secretary to receive their copy.

The Club shall acknowledge a member's illness, death or other concern with an appropriate card. Exceptions to this rule shall be voted upon by the general membership or directors as occasions arise.
