A Board Meeting was held on November 7, 2019 and the minutes from the September 29, 2019 General **Membership Meeting** were approved as written. Treasurer's Report: There was no financial activity during August. In September, Insurance was \$730.25, Conference Calls totaled \$54.52, Staples was \$83.11, and there was a deposit of \$150 leaving a beginning balance of \$8002.53 for October. October bills were: Staples for \$57.13, Reimbursement to Pam Grav for Show Ribbons - \$235.00, and a \$100 check to Caroline County 4-H for the deposit for the Showgrounds. This leaves a current balance of \$7610.40 for the beginning of November.

Prior to the newly elected treasurer taking office in January, an Auditing Committee will be established to review the treasury books. George Parris will be recruiting the Audit Committee Members.

A discussion ensued regarding our current web host provider iPage. It was decided to maintain this current webpage for an additional year to assess the activity and usefulness. The General Membership will be asked for their input as well.

The 2020 Spring Pleasure Show Committee is in the process of finalizing the Judge selection. Several suggestions have also been submitted for classes and the order of go, which the committee is taking under advisement. The Show Committee is actively meeting and will keep the Board apprised of progress.

Scam Email

Recently several club members were the recipients of scam email and this was reported to a phishing site. Phishing is a type of online scam where criminals send an email that appears to be from a legitimate person or company and asks you to provide sensitive information. This is usually done by including a link that will appear to take you to the company's website to fill in your information – but the website is a clever fake and the information you provide goes straight to the crooks behind the scam.

The term 'phishing' is a spin on the word fishing, because criminals are dangling a fake 'lure' (the email that looks legitimate, as well as the website that looks legitimate) hoping users will 'bite' by providing the information the criminals have requested – such as credit card numbers, account numbers, passwords, usernames, and more.

What Can You Do? First, don't take the bait. Phishing emails and text messages may look like they're from a company you know or trust. Phishing emails and text messages often tell a story to trick you into clicking on a link or opening an attachment. Your email spam filters may keep many phishing emails out of your inbox. But scammers are always trying to outsmart spam filters, so it's a good idea to add extra layers of protection. Here are four steps you can take today to protect yourself from phishing attacks.

- 1. Protect your computer by using security software. Set the <u>software to update automatically</u> so it can deal with any new security threats.
- 2. Protect your mobile phone by setting software to update automatically. These updates could give you critical protection against security threats.
- **3. Protect your accounts by using multi-factor authentication.** Some accounts offer extra security by requiring two or more credentials to log in to your account. This is called <u>multi-factor authentication</u>. The additional credentials you need to log in to your account fall into two categories: Something you have—like a passcode or Something you are—like a scan of your fingerprint, your retina, or your face. Multi-factor authentication makes it harder for scammers to log in to your accounts if they do get your username and password.
- **4. Protect your data by backing it up.** Back up your data and make sure those backups aren't connected to your home network. You can copy your computer files to an external hard drive or cloud storage. Back up the data on your phone, too.

If you got a phishing email or text message, report it to reportphishing@apwg.org. The information you give can help fight the scammers.





DIY Barn Projects

Make Your Own Pumpkin Horse Treats



Ingredients

1½ cups oat bran 1/2 cup sweet feed 1/2 cup quaker oats ½ cup sprouted pumpkin chopped seeds. 1/4 cup all-purpose flour tablespoon 2 large carrots, chopped cup molasses cup brown sugar ½ cup canned pumpkin An old plastic barrel can easily be turned into a practical and organized way to keep extra halters and leadlines near your pasture gates.



- 1. Preheat oven to 300 degrees and grease mini muffin tins.
- 2. Chop your pumpkin seeds and carrots. You can also buy pre-shredded carrots
- 3. Mix your dry ingredients in your stand mixer.
- 4. Add the wet ingredients and mix.
- 5. Spoon your mixture into your mini muffin pans. The mixture will not rise so you can fill each muffin bowl to even.
- 6. Push a pumpkin candy into the center of each muffin and pull it back out leaving an indentation. Use one candy to do all of the muffins.
- 7. Bake for 50 minutes. Remove from the oven and add the pumpkins into the indentations.
- 8. Bake for 5 more minutes. Then let cool in the muffin tin for 10+ minutes before you turn them out of the tins onto a cooling rack to completely cool.


